BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF \$3,895.00

Our charge for basic services includes but is not limited to the services of our funeral directors and staff to respond to initial request for service, the arrangement conference, arrangement of the SendOff event, filing of necessary authorizations and permits, recording vital statistics, placement of obituary notices, staff assistance before and following the SendOff, including coordination of service plans with cemetery, crematory and any other parties involved. Overhead costs relative to our facilities, professional licensing, legal and accounting, insurance, utilities, maintenance, taxes, furnishings, inventory costs, and administrative expenses are included in this charge.

This fee for our basic services and overhead will be added to the total cost of the SendOff arrangements you select. This fee is already included in our charges for direct cremation, immediate burial, and forwarding or receiving of remains.

PREPARATION OF THE DECEASED

Embalming and restorative arts \$595.00

Except in certain cases, embalming is not required by law. Embalming may be necessary if you select arrangements such as a funeral with a viewing. If you do not want embalming, you usually have the right to choose an arrangement that doesn't require you to pay for it, such as direct cremation or immediate burial or where refrigeration or the use of dry ice is available.

Facilities, equipment, and staff for a SendOff event	\$2,000.00
Our services will include set-up and use of visitation/gathering area, placement of casket, urn or memorabilia. Use of equipment, display of floral arrangements, direction of visitors, and general supervision. Up to 5 hours on the day before the SendOff at a local facility, also includes 1 hour of visitation on the day of a formal service, when desired as a separate memorial event. Our services include the use of equipment and staff to coordinate the SendOff event at another local venue.

Minnesota law does not require you to purchase a casket for cremation. If you want to arrange a cremation, you can use a cremation container. A cremation container is a combustible, closed container that encases the body and can be made of materials like fiberboard or corrugated cardboard and into which a dead human body is placed prior to insertion into a cremation chamber for cremation. The containers we provide are cardboard. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are cardboard.

There is no charge to you for our services in buying these items; however, we ask the family to reimburse us for these expenses within 7 days after event date. These items may include cemetery expenses, cremation authorization, venue fees, printed materials, musicians, florists, caterers, hairdresser, obituary notices, airline transportation, etc.

Selecting funeral arrangements for a loved one involves many decisions by family members making these arrangements. Not only are you accepting the moral responsibility of planning the service, you are accepting the financial obligation of paying the expenses associated with these funeral arrangements.

To assist you in making a decision on how best to satisfy these expenses, we offer the following options for settling your funeral expenses:

- Account paid in advance through Prepaid or Prefunded Funeral Arrangements.
- Assignment of insurance policies which are in good standing to cover a minimum of 50% or the total expenses with any outstanding balance due within 15 days of receiving the insurance proceeds.
- Payment of Third Party/Cash Advance Items due at completion of the funeral service with the balance due within 30 days from the date of the contract.
- We accept Visa, MasterCard, Discover, and American Express. We will add a 3% service charge of your total bill if you choose this payment method.

We do not bill Estates. If we have assisted you with third-party items (cemetery charges, honorariums, flowers, etc.), payment is to be made for these items within 7 days after the event.
